# INTRODUCTION

1. In the relevant civil complaint filed before, 24-CIV-07467<sup>1</sup> on the 24<sup>th</sup> of Nov 2024, the plaintiff presented examples of avoidable cases of damages, or strikes, among others, by Meta platforms which grind to halt, or sabotaged, among others, unique products, or services, or innovative academic researches, or platforms, or causes, among others, built one person, research method, milestone, project, activity, campaign and content, among others, at a time over the course of many years instantly. In addition, in the subsequent response to the demurrer to the complaint<sup>2</sup>, the plaintiff, among others, iterated, “Meta Platforms — which is headed by Mark Zuckerberg, CEO, and relevant executives of Meta overseeing relevant operational matters then, including managing complaints indirectly, among others — failed to avoid significant harms, or damages, strategically and operationally, among others.” Moreover, the plaintiff, in the subsequent response to the demurrer to the complaint, iterated, “He isn’t a lawyer by profession and that in the same way as he ventured on taking authoritarianism against all the odds because most of his contemporaries who studied law and politics, among others, would not want to fight for good governance, the pro-see litigant, putting his heart and limited experience of law, would start a legal procedure after learning nearly all law firms he contacted were not willing to represent any case against Meta Platforms. Furthermore, the plaintiff iterated a) the defendant, or representative thereof, ignored/disregarded most of the strategic, outstanding, points, or harms, deciphered in the previous complaint, b) the unique, top-level, executive, accountable, non-symbolic, powerful, direct and indirect, respective roles, operational decisions and management and leadership tactics and strategies, among others, by Mark Zuckerberg, CEO and the corresponding executive team of Meta, among other relevant persons making operational decisions though it precluded how they shape the product, services, value propositions and value co-creation spheres, among others, of Meta Platforms in B2C(business to customers), B2B(business to business), B2G(business to government) and B2NG(business to non-government), among others, value-creation spheres, among others, in detail or with examples, c) a software product is manufactured, or produced, through commonly accepted software product manufacturing processes and methods, such as the software development life cycle (SDLC)<sup>3</sup>, among others, upholding customary, normative, technology methodologies, such as agile, among others, and that Meta’s AI software product, exhibiting a stored,

1 or computed, among others, property(or method)<sup>4</sup> of striking, or harming, or undermining, unique  
2 pages, or suppressing contents, or a product, or service, or vision, or causes, among others,  
3 discriminately, as demonstrated in sections A and G of the first complaint, under the category of  
4 product liability, a legal, or business, concept where manufacturers, or producers, of a software product  
5 would be liable for any damage, or loss, or harm, among others, caused by a defective software  
6 product, or application, or code, or service [whether intentionally, discriminately, to one party or  
7 because of professional negligence, or error, to multiple parties, among others.]. As a result, Meta's  
8 software product is expected to work impartially: "The lines of codes, or classes, or methods, or  
9 functions, among others, which form Meta's software product, or AI, as we may know and see it, must  
10 not discriminate similar contents time and again, d) unfair business practices by Meta, such as refusing  
11 to take down dangerous, abusive and violent, among others, contents [in some cases contents  
12 psychologically abusive and socially damaging to the plaintiff] though informed, among others, while  
13 disabling, or undermining, a unique page, or product, or service, or community, or political-power,  
14 among others, built one person, research method, milestone, project, activity, campaign and content,  
15 among others, at a time over the course of many years instantly by striking legit contents  
16 discriminately, e) Meta violated the civil, human and democratic rights of the plaintiff and millions of  
17 people represented by the unique, afflicted-citizens-centered, product, among others services rendered  
18 directly and indirectly, f) acts of professional negligence: "from the internal, organizational,  
19 representatives of Meta Platforms through fact checkers to the oversight board, conducts of  
20 professional negligence of failing to ensure the product, or services, of Meta platforms work  
21 impartially, or ethically, without bringing avoidable, significant, damages, were cited. For instance,  
22 when informed about unethical, or harmful, operational conducts, such as striking a legit content  
23 illegally, or refusing to take down violent, dangerous and abusive contents doing away with  
24 fundamental, normative, universal principles, Meta failed to uphold normative, professional and  
25 ethical business, or service delivery, processes and enterprise governance<sup>5</sup>(including architecture,  
26 among others) and customer-centricisime models, among others, less predisposed to causing critical  
27 damages time and again, g) the illegal, or unethical, strikes, suppressions, neglects and disparagements,  
28 among others, by Meta Platforms damaged the unique, innovative, first of its kind, scientific and

1 afflicted-customer-centric software product management research of Michael Argaw<sup>6 7, h)</sup> and, last  
2 but not least, Meta Platforms allowed several entities to defame, disparage and destroy Michael Argaw  
3 socially and politically, among others, time and again.

- 4 2. In this civil complaint, the plaintiff would like to iterate the following golden, normative, principles  
5 once and for the last time: “Can we imagine seconds, minutes, days, weeks, months and years where  
6 the service operations of Meta Platforms are interrupted, or significantly jeopardized, impeding the  
7 growth of Meta Platforms fundamentally in the real-time and prescriptively? Can we imagine a  
8 scenario where Facebook — Meta platforms’ most powerful social networking innovation which  
9 connects, powers and empowers billions of users across the globe<sup>8</sup>, serving as an indispensable option  
10 for doing business, networking with friends and families, entertainment, evangelization and  
11 fellowship, social education, citizen journalism and the steadfast promotion of human and democratic  
12 rights, among others — get disconnected, or isolated, from its users, or customers, instantly? Will the  
13 CEO, or the executive team of Meta Platforms, or Meta Platforms dependent(powered) pro-democracy  
14 activists, or opposition politicians in exile, or founders of popular games, or afflicted-citizens-  
15 centered-software-product-researchers, like me trying to promote democracy harnessing Facebook, or  
16 innovative digital products, or new innovative research methods, or citizen journalism, or creatives,  
17 among others, allow disruptions, undermining and exponential decline, among others, of the services  
18 of Meta Platforms. Not at all. Because, the CEO, the executive team and substantive users of Meta  
19 Platforms like myself — though we all are not perfect, may not have perfect partners, may not know,  
20 or are not experts in, everything and are not proposing our service offerings(which for scientific  
21 researcher, or scientist, and multidisciplinary product, political, social, service and fine art, among  
22 others, visionary Michael is liberating millions out of the bondage of tyranny and social  
23 entrepreneurship, among others) in a perfectly operating world — are there to make sure the products,  
24 or services, of Meta Platforms, such as Facebook and WhatsApp, among others, keep growing to the  
25 next level holistically without any disruption, decline and distress, among others, to any stakeholder

1 for seconds, minutes, days, fortnights, quarters and years. Imagine the corresponding emotional  
2 distress, negative feelings and hurts, churn of users and followers and loss of expected exponential  
3 impact, investments, growth, brand image, vested equity and organizational infrastructure, among  
4 other damages, which will be incurred and experienced in a scenario where the Facebook product, the  
5 production, management and exponential growth of which is architected by its CEO, among others,  
6 ceases to function normally unprecedentedly! Will the CEO, among others, of Meta Platforms, among  
7 others, allow, or keep quiet for months and years in the face of, acts disparaging, disrupting, impeding  
8 and undermining products, or services, they worked hard to raise up for over a decade? If I, for sure,  
9 can not say he will not, I firmly believe Mark Zuckerberg, among others, will do something when  
10 something disrupts the platforms, pages, services and product lines they built ground up over the course  
11 of nearly two decades of time. What if discriminatory(targeting an individual, or page, or product,  
12 research, or opinion, among others), or unfair, business practices, or professional negligence, among  
13 others, violating the normative terms of services of Meta, or Facebook, result in abrupt disruption of  
14 services to pages which, defying the state of emergency[at all cost] of regimes, represented the voices  
15 of over 100 million Ethiopians fervently. Isn't it the strategic role of the CEO and executives, among  
16 others, of Meta Platforms that respecting civil, or human and democratic, rights, ensuring the products,  
17 or services, of Meta work fairly and impartially, upholding community guidelines and normativism,  
18 deploying ethical, professional, standards of duty of care, among others, without causing any damage  
19 to private, public and non-governmental interests intrinsically, such as defamation, disparagement,  
20 emotional-distress and political, financial, social and cultural, among other, losses causing jeopardy  
21 and significant decline of a product, or service, or research, or vision and cause, among others. If the  
22 CEO of Meta Platforms, among others, are not responsible, or accountable, for the product,  
23 operational, customer service, technological, governance, financial and legal, among others, strategies  
24 they approve, oversee and reformulate, among others, who else has a de facto, strategic, executive  
25 leadership capacity and responsibility, among others, to ensure emotional distress, disparagement, loss  
26 of growth and the systemic suppression of the voice and democratic aspirations of millions of people,  
27 and entities, among others, will not happen by suppressing, undermining, jeopardizing, impeding and  
28 slowing down, among others, accounts, or products, or services, or causes, or political dynamics, or  
persons, or researches, among others, dependent on Meta Platforms. Can the CEO, or representatives,  
or executives, of Meta Platforms, or Facebook, imagine the exponential orthogonal damages and loses  
to growth products, ideas, pages, politicians and founders when Meta Platforms takes incorrect  
measures, or strikes, time and again while allowing other external entities(such as persons) to abuse  
the same person, or product, or service, or founder, among others, repeatedly[instance of which will  
be discussed refreshingly, and in detail, in section A of the substantive allegations subsequently]?"

3. In addition, in this complaint, the plaintiff will add more substantive allegations: “a) detailed account on how Meta Platforms allowed several entities to defame, disparage and destroy, among others, Michael Argaw socially and politically, among others, b) Meta Platforms disregarded the plaintiff’s legitimate complaint regarding outright discriminations reported, c) Meta Platforms prevented the edition of an influential live fiction [content] in the making impressing million times<sup>9</sup>, d) Meta Platforms intercepted an ongoing, emotional, promotion of a post, or content, criticising the mis-informative, value-distractive, conduct of Egypt doing away with a must have, honest, respectful, sovereign-equal and value co-creative cooperation premised on equitability<sup>10 11</sup> along the Nile, e) impeding the uninterrupted, holistic, growth and promotion of an idea strategically, Meta Platforms failed to process a legit ID uploaded to be able to continue running political, social and economic oriented creatives(ads) in the jurisdiction envisaged, f) and Meta Platforms prevented ads released from the social entrepreneurship education platform, EntrepreneursinFinland<sup>12</sup>, for unknown reasons, impeding the corresponding growth of the page, or product, or service, among others, strategically, among others.

4. Moreover, in this complaint, the plaintiff will discuss how a) the corresponding wrong strikes, b) product, or service, failures, c) discriminations, d) civil, human and democratic rights violations, e) in what could be, “a failure, or indifference, in the strategic management of an enterprise architecture, or governance system,” which, deviating from the common, universal, expressly-stated, fundamental and bi-partisan, among others, mission, values and vision, among others, of Meta Platforms, allowed open and multi-dimensional, among others, public defamations and attacks on Michael Argaw strategically time and again directly and indirectly, f) wrong and discriminate interferences on Facebook ads, g) the delayed and intercepted processing of the corresponding ID required to be able to run creatives on political, social and economic issues, h) indifference to corresponding timely by Meta Platforms caused high-level damages in concrete social, political, financial, academic and economical, among

## SUBSTANTIVE ALLEGATIONS

### **A. Detailed substantive allegation on how Meta Platforms allowed several entities to defame, disparage and destroy Michael Argaw socially and politically, among others.**

6. Example of deliberate, mis-informative, fictions, or value-destructions, carried out on Michael Argaw publicly<sup>16</sup>

7. In the post above, according to Figure 1, Amarawitu Amara(Menen Hailemariam), a Facebook influencer followed by tenth of thousands, if not over 100K, made a deceitful libel, or defamation, or disparagement, or mis-information, or hybrid-warfare, against Michael Argaw. “Michael. Even that prostitute breeding mother of yours will not be left. I will take on her as well tomorrow. Calling names ... I will get you to bleed blood. Michael, you are sticking with old white ladies,” said Amarawitu Amara(Menen Hailemariam). Everything Amarawitu said is false. There is not any single word which is a) right, b) true and c) permissible for public disclosure regarding the personal meta data(information) of Michael Argaw in anyways or by any means. While there is not any doubt Meta

9. In the post above, according to figure 3, Michael is pausing for a moment of picture with the conscripts of the defence forces of Finland. In addition, Michael tells what he also does with Chewata: “That he has a unique role: Human Rights Officer” It is evident, no matter how anyone would want to interpret his role, promoting civil, human and democratic rights, win-win preferential option for good governance and social justice, among others, the post does not mention anything against Amarawit

Wello(Menen Hailemariam) in any ways, or by any means, intrinsically. Nonetheless, Amarawit Wello(Menen Hailemariam) would engage in making a deceitful libel, or defamation, or disparagement, or mis-information, against Michael Argaw. While there is not any doubt Meta platforms did not write the civil, human and democratic, rights violating content above, the irresponsible management tactics and strategy deployed by its leadership, which is entrusted to ensure no, or the least possible, harm would occur to a member of the community time and again, allowed Amarawitu Amara(Menen Hailemariam), among others, to carry out hybrid warfares, or deceitful libels, or defamations, or disparagements, or mis-informations, against Michael Argaw time and again.

In the post above, according to Figure 4, Haileyesus Adamu, attaching a publicly recognizable picture of Michael Argaw taken from one of his posts on Facebook, wrote an objectionable, defamatory, fiction, or libel, or disparagement, against Michael Argaw. “This is Mikael Aragey. Claiming he has families in Wello, he has been cheating money. He is from the Tigre tribe. He claims he is professor, engineer, Tegabru Gobeze. He has a Tigre account by the name Semay Giratu. He claims to be Kimant as well. He has also got an Oromo account. I have attached all his accounts here with. We had him in our camp by mistake, and he would register the name and logo of our organization in Finland and attempt to cheat others by claiming our organization belonged to him falsely. They say he is crazy. He is a Tigre prostitute. He is using the aforementioned accounts to insult Anegu, among others. He is a dirty Tigre,” said Adamu unabridged. 3 residents of Addis Abeba in particular [a) that Addis Abebians have yet got to exercise the right to  
4 self-administration, b) and Addis Abeba — though having a population, economy and concentration  
5 of elites, among others, surpassing some regions in Ethiopia — has yet got to be represented in the  
6 federal parliament of Ethiopia equitably with an estimated seat ranging from 70 to 200], Michael  
7 Argaw is a pro-democracy campaigners, or one of the few genuine opponents of the regime in Ethiopia,  
8 who executed games, scientific researches, digital campaigns, ads, citizen journalisms, scribblings and  
9 historical interpretations, among others, shaping contemporary politics in Ethiopia, promoting an end  
10 to tyranny, the promotion of free and fair periodic elections, peaceful transition to democracy through  
11 a product, research, service, idea, philosophie, updates and opinions, among others, aimed at advancing  
12 democracy, economy, development and constructive interpretation of history, among others.  
13 Nonetheless, Adamu — as part and parcel of his hybrid strategy, mis-categorizing Michael along with  
14 the operatives of the regime superstitiously deliberately — would campaign against Michael  
15 deceitfully. Subsequently, there is not any doubt Meta Platforms is not liable for the conduct of the  
16 users of the platforms. Nevertheless, Meta platforms could have avoided repeated and avoidable

26 because Meta allowed intensive and extensive disparagement, or libel, against Michael from different  
27 parties unethically. Adamu has been attacking several individuals, such as artist Teddy Afro, among  
28 others. Again, if Meta platforms, which did not co-create the posts with Adamu, took decisive actions  
on Adamu, such as striking the contents in due time, the exponential damages on Michael, among

3 people-centric, personal-branding, democracy-empowering, personal-building and product-led

5 positioning entity on earth, according to the subjective opinion of the plaintiff. Subsequently, Meta’s  
6 content qualification and oversight team — which is managed by the strategic team of Meta directly  
7 or indirectly, which is headed by Zuckerberg — was negligent, or complicit, or indifferent, in the face  
8 of repeated violations of Meta’s guidelines, or mission, vision and values, or civil, human and  
9 democratic, rights, on Michael. As a CEO and members of the executive team leading one of the most  
10 people-centered and product-led tech organization on earth, it is incumbent upon Mark Zuckerberg,  
11 among others, no person(whether one of the few contemporary political philosopher opposing the

Although informed about the plaintiff's difficulty of merging two related pages then under Job ID 1331531981025402, Meta Platforms disregarded the plaintiff's legitimate complaint by claiming "the pages are merged" falsely, violating normative, professional and customer-centric standards fundamentally, delivering implausibly care-less service deliberately consciously.

**D. Meta Platforms prevented the edition of an influential live fiction content in the making impressing millions times**

14. Impeding its corresponding exponential growth, or democratic cause, or envisaged social, political and cultural, among others, impact, or the strategic, high-level, objectives, among others, of the brand negatively, Meta Platforms prevented the edition of a well-pivoted, validated, growing and influential live-fiction which garnered over 17K likes<sup>23</sup>. In addition, by forcing a public disclosure, Meta Platforms — an entity of which mission, vision and values doesn't preclude promoting human and democratic rights while protecting those who put themselves in the front line to advance causes of democracy — jeopardized an imperative private interest of security, or anonymity, among others, strategically when, or because, there, apparently, arised a need for making public complaints or disclosures. In the picture below, it is evident it is not possible to edit through the ongoing work of fiction in the making. Furthermore, the video link here with referenced shows the last time when the corresponding content was edited, when it was permissible to edit and the duration of time the right to edit the fiction was prevented indirectly<sup>24</sup>. Again, by impeding the unique, impactful, politico-cultural, among others, service<sup>25</sup>, or fiction, touching from corruption through rape to authoritarianism, among others, Meta Platforms interfered in the high-level, politico-cultural and politico-economical, among others, arena of Ethiopian politics negatively by controlling the legit, democratic, causes, propagations and indoctrinations, among others, promoted, or contemplated, in the corresponding trending, very impactful, post, or page, or brand, strategically intrinsically unfairly.

15. Damages arising from suppression, or obstruction, of civil, human and democratic rights: "For every day, or year, the work of fine art in the making get impeded, the envisaged, strategic, high-level, politico-cultural, impacts, or objectives, hypothesized through the fiction directed, among other exponential brand value propositions and developments in the making, get jeopardized strategically unequivocally."




Figure 10: Meta impeded the edition of Dr Health<sup>26</sup>, an influential live fiction in the making.

15. The interfered, or intercepted, post has two parts<sup>27</sup>: “A video blog and a swift scribbling.”




Figure 11: The post which was promoted temporarily was intercepted from promotion subsequently.

influenced western philosophy and culture through his writings tremendously.

- 1 25. Until the 1960s — when King Haileselassie, one of the founding fathers of African union,  
2 intercepted bringing bishops from Egypt just like King Sisinius — Egyptian bishops (some of  
3 whom were Muslims disguised as Christian clergymen superstitiously instead) would control the  
4 politics, pedagogy, diplomacy, culture and economy, among others, of Ethiopia tactically and  
5 strategically proactively for many centuries.
- 6 26. Pedro Páez Xaramillo, sj(born in 1564 in Olmedo, Spain, who died on May 20, 1622, in Gorgora,  
7 Gonder, Amhara, Ethiopia) wanted to build a canal to transform Ethiopia in about the same time  
8 as the Dutch, among others, were building canals across Europe. However, Egyptian bishops  
9 running the Ethiopian Coptic Church who had a distorted and unsustainable notion of aquatic and  
10 environmental(ecological) value proposition in their head prevented the Jesuit missionaries from  
11 taking any ground and promoting civilization in Ethiopia. For instance, modern education, or  
12 acculturated, or structured, clergy, or minister, formation the likes of Catholics and protests —  
13 which would have got Ethiopia to be in par with Europe (in terms of the progress of its  
14 corresponding liberal education and civilization subsequently apparently) — was introduced very  
15 recently[though Ethiopia has been an old civilization].
- 16 27. Dealing with sense-less, devastating, civil wars and invasions, among others, Ethiopia was  
17 alienated, played out and insulated, among others, for many centuries. As a result, the Egyptian  
18 Coptic Church, or the elites of Egypt, controlled and molded the Ethiopian Coptic Church,  
19 religion, culture and politics, among others, for many centuries.
- 20 28. Although hard, obliterated and a painful fact to comprehend for anybody, isn't it tantalizing how  
21 Egypt commanded a systematic control and got Ethiopia and sub-Saharan Africa underdeveloped  
22 inside-out and outside-in exponentially, chronologically, discretely?
- 23 29. My theory — that the division of the universal church in the 4th century, as opposed to  
24 philosophical, or theological, is politico-economical oriented — is based my interpretation, cause-  
25 effect synthesis construction and morphological decomposition of the politico-economical,  
26 economic and cultural(including theological philosophies, among others) history, among others,  
27 of Europe, Egypt and sub-Saharan Africa since 1 AD chronologically.  
28

- 1 30. N.B: To be able to understand my [opinions of] empirical and rational interpretations, it is essential  
2 comprehending relevant historical, theological, cultural, economic and political facts, among  
3 others, patiently. For instance, when it comes to what's noted below, among others<sup>31</sup>.
- 4 31. That Alexandria, Egypt was prominent when it comes to water-intensive-products during the  
5 Roman empire.
- 6 32. That in the 4th century, Alexandria, Egypt was a net contributor to the Roman Empire until it left  
7 for politico-economic reasons which I contended, or mystified, above.
- 8
- 9 33. That Alexandria, Egypt wanted to disassociate from the Roman Empire.
- 10 34. That Alexandria, Egypt wanted to associate to, and control, the source of the water.
- 11 35. That Alexandria, Egypt managed to associate and control Ethiopia subsequently.
- 12 36. That Alexandria, Egypt controlled the pedagogy, politics, culture, religion and economy, among  
13 others, of Ethiopia, among others, super-culturally (and sub-culturally derivatively) subsequently.
- 14 37. The Southern Atlantic Ocean was called, "Ethiopian Sea, or Ocean," in several manuscripts for  
15 centuries.
- 16 38. 1750-1850 was the era of Zemene Mesafint, or endless wars, in Ethiopia.
- 17 39. 1930-1974 was the time of King Haile Selassie (Tefere Mekonen).
- 18
- 19 40. In the 18th century, Ottoman Egypt's primary exports included textiles (raw cotton and cotton  
20 yarn), grain (particularly rice and wheat) and raw materials, among others, instrumental for the  
21 industrial revolution as we may read and interpret it.
- 22 41. The first industrial revolution, which started in Great Britain, spread to continental Europe, such  
as France, Belgium, German states and US between 1760-1840<sup>32</sup>.

43. The industrial revolution was marked with advancements in textile manufacturing, production of iron and innovation of steam engines, among others. One important empirical and rational observation: "While civil wars [sponsored by foreign actors] were going on in Ethiopia, the industrial revolution was elevating Europe and US to new heights of manufacturing.<sup>33</sup>"

44. 11 February 1855 - 13 April 1868 was the period of the reign of King Tewodros who, losing in the Meqdella war to the invading British expeditionary forces, committed suicide [there and then] in Maqdella, Wello, Ethiopia. The overthrow of Tedros prevented Ethiopia from consolidating its unification and utilizing its water potential tremendously strategically while enabling French and British, among other held aquatic economic activities along the Nile, to source much needed raw materials and finished (and partly finished) goods which powered the industrial revolution strategically, according to my empirical and rational observation and interpretation of industrial (or economic) history morphologically discreetly.

45. Tekle Giyorgis (11 June 1868-11 July 1871).

46. Yohannes 4th (11 July 1871-10 March 1889).

47. Menelik 2nd, King of Shewa (1866-1889).

- 2 53. The first Italo-Ethiopian war (1895-1896). During the time of the scramble for Africa, Italy would
- 3 attempt to colonize, or own, Ethiopia. The victory of Adwa was the first, successful, anti-
- 4 colonization victory by an African country. The war, apart from putting Ethiopia hundreds of years
- 5 behind from actualizing industrial revolution, left a legacy: "The corresponding defeat galvanized
- 6 revanchist sentiments in Italy which resulted in the subsequent invasion of Ethiopia in 1935."
- 7 54. 1898-1902: construction of Aswan Low Dam in Egypt.
- 8 55. 1898-1903: construction of Assiut dam, the first reservoir in the Nile which stretches up to
- 9 560KM.
- 10 56. The reign of Lij Eyasu (1913-1916)
- 11 57. The reign of Empress Zewditu (1916-1930)
- 12 58. The second Italo-Ethiopian war (October 1935-February 1937)<sup>35</sup>
- 13 59. The 1959 bilateral agreement between Sudan and Egypt, upholding the previous, fallacious,
- 14 bilateral treaty, increased the corresponding allocated water to the bipartite parties preposterously:
- 15 "Allocating 55.5 billion cubic meters of water, 18.5 billion cubic meters of water and 10 billion
- 16 cubic meters of water to Egypt, Sudan and evaporation and seepage respectively, the treaty called
- 17 for the joint construction of the Aswan High Dam in Egypt and the Roseires dam in Sudan, among
- 18 others."
- 19 60. 1954-1960: Aswan High Dam
- 20 61. 1954-1960: The closure of the Suez Canal due to the second Arab-Israel war.
- 21 62. In 1955, Nasser pronounced himself as the leader of the Arab nationalism.
- 22 63. Ethiopia inaugurated the port of Haseb, Eritrea in 1961.
- 23 64. In 1961, Idris Mohammed Adam and other Eritreans (Ethiopians then) founded the Eritrean
- 24 Liberation Front as a pan-Arab movement in Cairo, Egypt. Nonetheless, the first act of armed
- 25 resistance was led by Hamid Idris Awate.

- 1 65. Founding and decline of the Eritrean Liberation Movement (1958-1959)
- 2 66. Formation of the Eritrean Liberation Front (1960-1962)
- 3 67. In 1960, adopting the tactics used by the national liberation front of Algeria, Egypt started training  
4 Eritreans (Ethiopians then) rebels in Alexandria. In addition, Egypt provided multidimensional  
5 resources for media and insurgency, among other campaigns, against the territorial integrity,  
6 development and prosperity of Ethiopia strategically. For instance, Woldeab Woldemariam  
7 bombarded Ethiopia with different types of insidious, ulterior, propagandas from Cairo  
8 relentlessly. Most of the founders of the pan-Arabic movement of ELF (Eritrean Liberation Front)  
9 were Muslims while the ruling class in Ethiopia was Christian for the most part. As a result, Egypt  
10 Mobilized broad-based support for ELF from the Arab League which foresaw the strategic  
11 importance of controlling the Red Sea and Ethiopia discretely to helping fellow Muslim allies  
12 challenge Ethiopia from with-in, pledging support to ELF in 1962. Furthermore, Sudan allowed  
13 ELF to transfer weapons and organize military operations. Nonetheless, the US, signing a secret  
14 packet with Ethiopia, affirmed its opposition to any insurgency against Ethiopia commanded from  
15 Egypt [ but only] for some time while denying access to finance and marshal-aid (which was given  
16 to a non-ally Germany) discretely<sup>36</sup>.
- 17 68. 1960-1970: The construction of Aswan dam in Egypt by the military regime which took power  
18 following the revolution in 1952.
- 19 69. On the 1st of September 1961, ELF, under the leadership of Hamid Idris Awate, fired the first  
20 shot in its battle touted as that which was done for independence ulteriorly strategically.
- 21 70. Idris Mohammed Adam(1922-2003), president of the Eritrean Assembly and prominent leader of  
22 the ELF, was born in Akordat, Eritrea. His father was a farmer who moved to Sudan and joined  
23 the Sudanese army in Ghedaref. As a matter of fact, Idris, under the care of the intel of Sudan, did  
24 his elementary studies in Sudan<sup>37</sup>.

4 community in Yemen and North Kenya, among others.
- 5 73. TPLF (Tigray people's liberation front) — which is a member of ENLF — would come out of a  
6 student movement in the 1960s.
- 7
- 8 74. In 1973, the Wello Famine, an artificial drought which killed 40k to 200k people at least,  
9 jeopardized the reign of Haile Selassie who, putting aside his plan for construction of dams, among  
10 others, was busy maintaining the territorial integrity of Ethiopia primarily.
- 11 75. 12th of September 1974: Dissolving the Crown Council and Imperial Court, and disbanding the  
12 emperor's military staff, the Derg regime began detaining PM Endalkachew's closest advisors.
- 13
- 14 76. The Ethiopian Revolution (12 September 1974 to 28 May 1991) was a tremendously devastating  
15 period of civil, political and military, among others, upheaval in Ethiopia which misguided and  
16 undermined all stakeholders in the country strategically. The culprits: "Both the superstitious and  
17 preposterous regime, and its corresponding opponents and foreign actors."
- 18 77. In 1975, Aregawi Berhe founded the Tigray People's Liberation Front.

21 race to the bottom for the most part intrinsically.

- 23 79. 1983–1985: Due to the occupation of most parties, such as regions, states, farmers, elites and

25 there was a widespread famine in Ethiopia. In the fall of 1984, northern Ethiopia was hit with  
26 artificial droughts. As a result, lots of people died in Tigray, Wollo and Eritrea.
- 27 80. Meles Zenawi, President of Ethiopia from 1991 to 1995.

1 81. Eritrea, land-locking Ethiopia effectively, would declare its independence and gain international  
2 recognition (with the leading support of the Arab League) subsequently in 1993, without the  
3 consent of the people of Ethiopia fundamentally<sup>38</sup>.

4 82. Meles Zenawi, Prime minister of Ethiopia from 1995 until his death in 2012<sup>39</sup>.

6 83. In 2008, without the knowledge and consent of ethnic Amharas residing in al-Fashaga, Ethiopia,  
7 TPLF-EPRDF led Ethiopia, in what many suspect as “a transitive deal,” agreed the al-Fashaga  
8 region would be incorporated as part of Sudan while allowing Amhara farmers to continue living  
9 there undisturbed<sup>40</sup>.

10 84. 6 May 1998 – 18 June 2000: Yet another senseless, insane, devastating, preposterous and  
11 superstitious war broke out between Eritrea and Ethiopia across Badime, Zal Anbesa and Bure,  
12 among other, regions<sup>41</sup>.




Figure 13: The corresponding notification of rejection.

**F. Meta Platforms failed to process a legit ID uploaded to be able to continue running creatives in the jurisdiction envisaged, impeding the uninterrupted, holistic, growth and promotion of an idea.**

91. Although the required legit ID was uploaded, Meta failed to verify an ID which has been uploaded, verified and used before in due time. Through its inconsistent conduct, Meta a) impeded the inorganic(promoted) growth of the corresponding post, page and idea, among others, b) resulted in avoidable emotional distress as usual, among others. In addition, due to Meta’s further delay in verifying the ID uploaded, the corresponding creative, or ad, attached to the post is not running anymore. Behold isn’t the first time Meta, citing selected political posts discriminatively, rejected, or intercepted, ads aimed at promoting posts which can’t reach otherwise, or organically, as the page had already been jeopardized as outlined in the previous substantive allegations, citing social, political and economic issues discriminatively.




Figure 14: Meta failed to verify a legit ID the likes of which was uploaded and verified before in due time.

**G. Meta Platforms prevented ads released from the social entrepreneurship education platform, EntrepreneursinFinland, for unknown reasons.**

92. A product out of service currently, Notacit — which was known as entrepreneursinFinland before — garnered around 2K visitors a day to its corresponding entrepreneurship-education-crowd platform, [www.entrepreneursinfinland.net](http://www.entrepreneursinfinland.net), for couple of years. Meta Platforms impeded the organic growth of the well-pivoted, well-validated and growing product by blocking the corresponding ads released from the page and preventing the sharing of the page's educational(entrepreneurship) contents to relevant groups, among others, time and again discriminately, leading to inhibition of exponential growth and scale up strategically.




Figure 15: Example of a content shared in the fan page of EntrepreneursinFinland.




Figure 16: Example of a content shared in the fan page of EntrepreneursinFinland.




Figure 17: Example of a content shared in the fan page of EntrepreneursInFinland.

93. The objectives of the pages, products, services, scientific research, interpretations, updates and causes, among others, are:
- ✓ To liberate over 120 million Ethiopians from tyranny using non-violent, or truly intellectual, means.
  - ✓ To counter established cultural and political local and foreign, among others, forces in the private, non-gov and state, among others, spheres weighing on the transition to bi-partisan democracy of Ethiopia negatively.
  - ✓ To inform, educate, inspire, equip and challenge, among others, all Ethiopians, or Ethiopian elites, in the Ethiopian political ecosystem, among others, about bi-partisan democracy, historical mistakes made and the way forward, among others.
  - ✓ To expose, correct and avoid human and democratic rights violations(Behold also applies for some of the contents related to Finland)
  - ✓ To campaign against injustices, or political structures, or political parties, or regimes, among others, violating the human and democratic rights of the people of Ethiopia. As a matter of fact, the pages under dispute with Meta are the first and the only in the history of politics in Ethiopia {especially in the run up to the resignation of TPLF(EPRDF), which has been in power for three decades, after the public, including US senators, said, “Game Over to TPLF,” } to execute ads of which score is 100% most of the time.
  - ✓ To carry out diplomacy, such as pressuring the regime in Ethiopia to transition to democracy.
  - ✓ To revolutionize science and technology, teaching, showing and experimenting how afflicted-citizens-centered, among others, software product management projects can be managed scientifically.

While Facebook has been one of the enabling, supplementary, force, or tech, to meet the envisaged, key, strategic, objectives, its careless, or irresponsible, among others, conducts, which was inconsiderate of dependency, damaged reliance, value co-creation spheres, products, services, political causes, scientific research, indoctrinations, solutions and campaigns, among others, built, achieved and set to grow at scale, among others, to change, or impact, Addis Abeba, the nations and nationalities of Ethiopia, the future of Nile and the economy, industry, politics and culture, among others, of Ethiopia, among others. As a result, Meta’s wrong actions damaged what was done regarding the future of the Nile, Ethiopia, Africa and the world, among others, socially, culturally, politically and scientifically, among others. Subsequently, the exponential, orthogonal, damages — which aren’t as simple, replaceable, scalable and compensable, among others, as calculating the corresponding cost for compensating damages arising from dozens of sky scrapers in New York city, SF and Austin, among others, set ablaze by accidental fire, among others — are enormous not only to a private party, the plaintiff, but also to the public. For instance, the high-level, strategic, objectives iterated above — which transcends from personal, business and academic, among others, objectives to the meta-quest for democracy by over 100 millions — have all been jeopardized or damaged. Everything that was done, and put into the making, such as skill, time, motivation and momentum, knowledge, acumen, rigorous-readership, hard-to-find-and-earn-insider-intel, innovative-scientific-frameworks-for-meeting-the-need-of-affiliated-citizens and management-frameworks, among others, have been damaged. 95. For instance, if, and when, you’re doing a restaurant business, your functional data elements are meals or forming and shaping thereof to hundreds of customers a day, if you’re running a car manufacturing industry, your functional data elements are shaping cars or parts thereof, if you’re running Amazon, your functional, business-data, elements are SAAS, PAAS and IAAS, among others. Given the high-stakes, and portfolios, among others, encompassed, when controlling, or randomizing, or shaping, among others, politics with unique ideas, opinions, innovations, researches, frameworks, interpretations and causes, among others, in an operational setting where the media landscape is dominated with similar opinions, which don’t represent the silent majority of the oppressed and exploited people of Ethiopia — when you run, or manage, among others, well-validated, high-level, political products, or services, or leadership tactics and strategies, or causes, among others, shaping at high-level, your functional, business(operational or political)-data, elements are natural resources, people, organized actions, movements, supply-chains,

1 executive decisions, markets, industries, powers, economies(both micro and macro), futures and  
2 world, among others— you are operating as a political, social, economic, cultural and financial,  
3 among others, force. In this regard, due to the strikes, among others, what was vested, and all that

18 97. Looking at some of the skills and acumens used, if we take some aspects of the contents alone, it  
19 usually takes a lot of reading and reflection, among others, before dropping few lines of unique  
20 contents, or reflections, among others, aimed at meeting unique goals, to convert one person at a  
21 time. The loyal user, or follower, bases in the corresponding pages which could have been, or were  
22 envisioned for becoming, a springboard for the next Disney-for-Democracy, among others, have  
23 been decimated. Instantly, Meta disabled, or abolished, not only a service, or product, among  
24 others, but a challenging cultural, or political, power, or brand, which was built one person,  
25 content, activity, research, research method, milestone, impact and impression, among others, at a  
26 time over a course of many years instantly.

27 98. Meta sabotaged a unique, or one of the few, rising political force, or power, or service, or product,  
28 or venture, or culture, or revolutionary scientific research, among others, which, defying the

subsequent state of emergencies enacted by the Government of Ethiopia to deter and silence any form of criticism or opposition, shaped politics positively in a unique way in the best interest of the oppressed and exploited people of Ethiopia unceasingly. As the ultimate goal of the product, or service, among others, isn't limited to Addis Abeba and Ethiopia, Meta sabotaged a unique, rising, political force, or power, or service, or product, or venture, or culture, or scientific research, or order, among others, not only in Ethiopia, the Nile, Africa, the Middle East and Europe but in the world. Meta damaged the reputation of a person, ideas, product, services, political job and causes, among others. Meta interfered with, and shaped, the aforementioned objectives, among others, including politics, economy, culture and industries, among others, at high-level, strategically, in the shape, or mold, it wants, becoming an opposite party directly, violating its terms of service, operation and guidelines, among others, intrinsically.

99. Consequently, it is unfair Meta decided to shape, or control, against the pages, or research, or the strategic objectives of the product and services, or a person, or millions in quest for democracy, among others, becoming an opposite party directly and indirectly. For instance, controlling, or halting, the only pages which were running critical creatives(ads) opposing, exposing, showing, inspiring and teaching, among others, in a unique and scientific way, defying the regime's declaration of subsequent state of emergencies in a country of nearly 120 million, Meta randomized, or controlled, the much-needed, imperative, envisaged outcomes, objectives and results, among others, against several private, non-gov and public, among others, interests, holdings and futures, among others, intrinsically negatively.

100. Example of some of what was put into what was damaged by Meta exponentially orthogonally: "Even if we assume it's possible to fill all the skills and acumens utilized, such as business, marketing management, journalism, history and software engineering, among others, by paying different specialists, it is hard to find an Ethiopian willing to take the high-risk(due to the level of criticality of the activities) to accomplish even specific, supplementary, tasks designated<sup>61</sup>. In addition, the thoughts, interpretations, insights, innovations(unique, well-verified-and-well-validated, research and developments methods, among others) and cultural and historical acumens, among others, which enabled the corresponding pages, products, services and contents, among

1 others, to convert one person at a time and result in the desired impact[even with negative controls]  
2 would haven't been possible without the unique, multidisciplinary, mind well-suited for that  
3 problem, or cultural and political spheres, as propagated through the products, works, services,  
4 contents and activities, among others. As a result, no-one would have [and as a matter of fact did  
5 evidently] accomplished the same, unique, critical, social, political and entrepreneurship  
6 innovation and alternative empirical and rational treatments to the pressing public, economic,  
political and industrial, among others, crises faced by millions of afflicted citizens.”

7 101. Examples of tangible skills and acumens put alone: “Marketing management, business,  
8 product-management, software-engineering, history, language, culture, fine arts, religion,  
9 industries and scientific-and-research-methods, among others.” The most important question, how  
10 much does it cost to find somebody willing to perform in 1) high-risk roles 2) cable of delivering  
11 those acumens and skills, [at the same time] having the personal story, brand, to be accepted,  
12 resonate to and convert one person at a time in critical, or radical, political value co-creation  
13 spheres where arts, culture, politics, science, history, theology and business, among others, are  
14 applied? If it was possible to find somebody ideating and executing the same, critical,  
15 multidisciplinary, thoughts, actions, service and scientific research, among others, where were the  
relevant academia when people needed alternative forms of bypassing and upending suppression  
62?

16  
17 102. For instance, what has already been damaged, and the cost for putting the knowledge, time,  
18 skill and effort, among others, vested to conduct afflicted-citizens-centered, innovative, cultural,  
19 political and technological product management research alone, precluding everything else for a  
20 moment, can be factored into considerations genuinely. Who is willing to conduct the afflicted-  
21 citizens-centered-research alone<sup>63</sup>? Who innovated regarding afflicted citizens in software product  
22 management for the first time in history? What was damaged by Meta — for instance, the  
23 scientific, afflicted-citizens-centered-software-product-manamgnet-research-and-innovation of  
Chewata with its academically, philosophically, morally, industrially, politically and culturally,  
among others, grounded anchors — had the potential to revolutionize the world as we may know

1 and see it. As a matter of fact, California isn't only the economic powerhouse of the US to date  
2 but also the politico-cultural powerhouse, or bastion, in which entertainment, such as Hollywood,  
3 and technology, among others, shaping the world, are concentrated. Meta's scandal is straight  
4 forward: "Meta went against the constitution, culture, values and reputation, among others, of  
5 California by suppressing strategic services, or scientific researches, or products, or causes, or  
6 fictions, among others, harnessing the power of arts, culture, business and technology, among  
7 others, to deliver democracy to millions creatively, upending suppression, or tyranny,  
8 innovatively, scientifically, academically, artistically and technologically."

9 103. Consciously and unconsciously, Meta violated not only the human and democratic rights of a  
10 private party but also millions indirectly intrinsically strategically.

11 104. By forcing disclosure, Meta jeopardized the security, integrity and reputation, among others,  
12 of a private party.

13 105. By forcing disclosure, Meta distracted, inflated and undermined a private party.

14 106. By discriminating contents, Meta harmed private, public and non-gov parties, or interests, as  
15 well.

16 107. The moment Meta prevented, or undermined, the strategic decision supports, provisions and  
17 some of the informations, knowledges, instructions, corrections, [empirical and rational]theories,  
18 ideas, products and services, among others, set on Ethiopia by striking, or undermining, among  
19 others, in the manner stated in the complaint, Meta decided what political idea and agenda, around  
20 who, and where and how, among others, people are allowed to organize, among others, indirectly.

21 108. For instance, the page, Addis Abebe, which is, and has been, the leading page advocating for  
22 Addis Abebians, was keen on campaigning for the release of political prisoners and the  
23 unequivocal and immediate respect for the right of Addis Abebians to pursue an authentic self-  
24 administration. Now that the page (which has over 113K followers) is out of use jeopardized by  
25 Meta, the political stride of Addis Abebians is jeopardized significantly.

26 109. For instance, due to the interruption, the hard-to-build cells, files and ranks built overtime to  
27 gather and communicate important info alone have been jeopardized or exhausted.  
28

110. The technical, social sciences and business, among others, rigorous learning curves needed to be met to supply input for what was in the making, and to come, subsequently, was damaged by Meta. Meaning, the process of bringing up what was damaged by Meta wasn't as simple as stopping, or damaging, everything done instantly but a long, risky and rigorous process.
111. Meta halted active, unique, non-violent, rare and hard-to-replicate-and-find, among others, political activities [which had sufficient momentum] capable of, or on course to achieve, undisclosed strategic, generational, political pro-visions [organized openly through social media, among others]. While the interferences may seem very easy for Meta, as simple as pressing a button, the instantaneous acts were critical to the state, development and future of several private, public and non-governmental interests directly and indirectly. For instance, the opposition political activity in Addis Abebab and Michael's ability to influence using social media has been intercepted for couple of years now. As a result, we are capturing damages on Michael lasting years, precluding damages to private, public and non-gov parties regarding the delay, or jeopardy, of the cause of the political advancement of the self-administration of Addis represented in the federal branches of the government of Ethiopia, among others.
112. Different actors would like to control power and politics, among others, in Ethiopia because apart from the sovereign jurisdiction of the country, whoever is in power in Ethiopia 1) can shape the current world order, 2) shapes African Union and Africa, 3) would determine the future of Middle East, 4) shapes Europe, 5) shapes Russia, religion, culture and the balance of east-west power and 5) shapes relation between China and Africa, among others. As a result, why Meta controlled in the mold, or shape, it did unfairly by discriminating, or striking, the corresponding democratic contents, scientific researches, products and services, among others, in the manner deciphered in the complaint is questionable strategically intrinsically.
113. What Meta damaged is a product, or service, or research, or community, among others, which — surpassing organized political parties which can't express critical points due to repression, among others — made a unique history in contemporary Ethiopian politics. Is it possible the investors, or, may be, corruption by its employees, influenced Meta to counter the democratization of Ethiopia? It remains to be deliberated coming up.

**H. Meta's Product chemistry: "Doing away with normative principles of product management, user centricism, among others, Meta platforms failed to implement simple features which could power, or align, users of Facebook to an enhanced strategic positioning or better outcome.**




Figure 19: A picture showing a post and users pending to be invited.

114. For instance, Chewata's post in Figure 19 enjoyed over 1.4k likes. If the manager of the page would like to invite those who liked the post to like, or follow, the corresponding page, he, or she, has to invite one person at a time. Positioning content creators, or businesses, or product owners, among others, in advantageous, strategic and organically prosperous value co-creation sphere, Meta could have implemented a simple feature which enables the invitation of all who have yet got to follow, or like, the page to follow, or like, the page at once in one button as opposed to the need for inviting one person at a time, giving users, or customers, an unpleasant, or cumbersome, test, or experience, of product chemistry<sup>64</sup>.

# I. Meta Platforms suppressed the live-streams from Michael's personal page, among others, repeatedly.




Figure 20: A picture showing a post and users pending to be invited.

115. In translating the aforementioned post, we get the following:

1 116. Translation starts below.

2  
3 117. Different types of terrorisms, sabotages and set-ups, among others, are unfolding on me in the  
4 US.

5 118. My drinking water supply gets interfered with chemicals aimed at sabotaging me emotionally,  
6 psychiatrically and physically, among others<sup>65</sup>.

7 119. The ventilator of the refrigerator, which inputs, or receives, a water diluted with psychoactive  
8 chemicals releases psychoactive vapour.

9  
10 120. Sounds coherent with my private activities on my connected mobile and mac devices get  
11 released from outside of my unit.

12 121. The home air system gets interfered with mind and emotion sabotaging and heart-rate altering,  
13 among others, types of chemicals. There are times when sounds will be made when the harmful  
14 air warfare agent, or biochemical, is released.

15 122. In addition, lots of things happened to me outside.

16  
17 123. There are times when even the bottled water which I bought from the supermarket has been  
18 diluted with harmful chemicals in different occasions<sup>66</sup>

19 124. The diet cock which I bought from couple of cafés in different occasions were poisoned with  
20 mind-debilitating drugs intended to undermine me emotionally, psychiatrically and intellectual,  
21 among others, temporarily and permanently.

22 125. I have been encountered with unwanted, intimidating, acts time and again, violating my data  
23 protection.

24  
25 126. I have been attacked with spray-agents by contaminating the air I may encounter ahead of me.

2 127. In most of the hotels and apartments I put up in the US, the water and air system would be  
3 tampered for carrying out bio-chemical attacks on my mind or nervous system. There are occasions  
4 where even when I said, “The hotel room is clean. As a result, I don’t need housekeeping,” they  
5 would insist on entering the room for cleaning, mob the clean-floor with detergents diluted with  
6 emotional-state changing chemicals.

7 128. The multi-dimensional domestic terrorism started in Finland in large scale on Sep 2023. Befor  
8 that it happened once in a while.

9 129. What could be the objective of the strategic attacks, or terrorisms, on me?

10 130. For instance, the biochemical attack could be aimed at inhibiting my ability to fight  
11 intellectually, so far up to disabling my brain, while countering my research[which, exposing  
12 years of severe human rights violations by several entities in Finland and tech(which from  
13 supressing my afflicted-citizens-centred research, innovation, product, service and political  
14 activity, among others, to introduce democracy in Ethiopia to different negative controls),  
15 produced new, innovative, service model canvases in a 300 page academic work<sup>67 68</sup>] through a  
16 weak hybrid strategy. In addition, it could be aimed at sabotaging and undermining me, my  
17 activities and country politically, among others, to make money, or limit liability, or protect  
18 interest, among others, by all means necessary.

19 131. My response to such type of domestic terrorism: “America doesn’t belong to any race, or  
20 ethnicity, but different ethnicities. If you want a tribal, or ethnic-dominated, administration system,  
21 then you have to go to Europe.”

22 132. Translation ends here

23 133. That Meta platforms suppressed the post above, I was forced to promote it. Meaning, I can’t  
24 promote strategic injustices happening on me aimed at not only jeopardizing my basic political  
25 activities and wellbeing but also the political and economic, among others, future of millions of  
26 people organically.

**J. Training a negative public learning control model, Meta Platforms suppressed the organic reach of the posts in the personal page of Michael, among others.**

134. While the personal page of the plaintiff, Michael Argaw<sup>69</sup>, has over 11K followers, Michael is forced to promote his posts because the organic reach of his page is compromised.
